AGENDA – 1: Final List of Beneficiaries for ‘Beneficiary–Led Individual House Construction (BLC)’ under Pradhan Mantri Awas Yojana – Housing for All (Urban).

The Chairperson, BMC informed the Councillors that in response to letter No. 6/6/2014-TP dated 19/02/2016 from the Chief Town Planner, Manipur / State Nodal Agency for PMAY-HFA, the Council conducted a demand survey in the entire municipality by inviting applications from urban poor living in kutcha/semi kutcha houses and belonging to the economically weaker section (EWS) for availing financial assistance for construction of individual houses in their own patta- lands under the sub-component – ‘**Subsidy for beneficiary-led individual house construction**’ of the **Pradhan Mantri Awas Yojana – Housing for All (Urban)**. A notification in this regard was first issued on 3rd March 2016 vide No. BMC/2/3/16-HFA(U) dated 3/3/2016, which was widely published through different media , viz. Local newspapers, door-to-door loudspeaker publicity; words-of-mouth publicity by the elected representatives (Councillors & Ward Members), social workers, NGOs, etc . With a view to cover each and every eligible urban poor and leave none, the council carried out another demand survey by issuing a 2nd Notification viz., 3/HFA/BMC/2016 dated 7/9/2016 which was again widely publicised. In response 1077 applications were received. These were subsequently, scrutinised and also cross-verified with SECC, 2011 data.

A house-to-house field verification of the applicants having discrepancies with SECC, 2011 data was carried out by a team of officers from Directorate of MAHUD, Government of Manipur and engineers from different Municipalities of the State on 27th November, 2016.


After the field verification survey, 102 applicants were found to be ineligible. Thereafter, the Council published a list of 912 preliminary beneficiaries through its Notification No. 2/3/HFA/BMC/2016 dated 28th November 2016 and invited claims and objections from the public to the said list. This Notification was similarly widely published through newspapers, AIR Imphal, Local Cable TV, door-to-door loudspeaker publicity, website, etc. The last date for receiving claim and objections was 1st December 2016.

129 claims and objections were received consisting of 63 cases of missed out forms, 31 applicants from the rejected list for reconsideration and 35 new submissions. Subsequently a second field verification was carried out in the morning of 2nd December 2016. After the field verification and cross examinations of documents, 123 applicants were accepted and 6 applicants were rejected.

Therefore, incorporating the above claims & objections for inclusion, exclusion and rectification, the **Final list of 1035 (One thousand & thirty five) beneficiaries and the rejected list of 77 (Seventy Seven) applicants** for 'Beneficiaries-led Individual House Construction(BLC)' under Pradhan Mantri Awas Yojana – Housing for All (Urban) for Bishnupur town has been prepared as per the list given in the ANNEXURE.

RESOLUTION-1 : The Council approved the Final list of 1035 (One thousand & thirty five) beneficiaries for 'Beneficiaries-led Individual House Construction(BLC)' under Pradhan Mantri Awas Yojana – Housing for All (Urban) for Bishnupur town as per the list given in the ANNEXURE.
