- 5. I / we shall be responsible for Civil and Criminal liability, if, particulars furnished are wrong, or undertaking given herein is not discharged properly.
- 6. I / we shall pay road restoration charges to the authority concerned.
- 7. I / we abide by the provisions of the Manipur Municipalities Act, 1994 and rules / Regulations / Bye-Laws or Orders / Directives issued thereunder.
